Sub : Urgent Need for Retrofitting of Bridge on Najafgarh Drain on Rohtak Road Highway near Ashoka Park (Main) Metro Station.

Respected sir,

On behalf of the residents of this colony I wish to bring to your kind notice one of the burning problem, likely disaster that may happen any time due to collapse of this bridge of its being structurally unsafe.

Some of the reasons of its likely collapse are as under :

1. The above stated bridge have outlived its life as it was built more than forty years ago using old technology and substandard material.
2. The projection of the traffic flow of this bridge has increased manifold thereby exceeding its load bearing capacity which this bridge is not in a position to withstand due to many colonies like Rohini, Pitampura, Pashim Vihar, Punjabi Bagh etc. have come up.
3. The structural analysis as well as the structural safety of this bridge when taken up may result with the fact that subject structure of this bridge may collapse at any time. This would be a great disaster for the vehicles moving on this Rohtak Road Highway Bridge.
4. Also the width of the bridge is not compatible with right of way available to this bridge, thereby there is a provision under which this bridge can be widened to take care of the vehicles flow on this Rohtak Road Highway Bridge.
