MEETING AGENDA

I am enclosing herewith the Agenda including the list of following works which will be taken up and discussed during our meeting on 26 February, 2014: Time 11:30AM.

West of Ring Road Area:

1. **Pitampura Village:** Relaying of Sewer System and connecting with the trunk Sewer.
2. **Harsh Vihar:** SW drains connected with Sewage System must be disconnected.
3. Mahendra Park, Raja Park, Srinagar – sewer system depends upon pumps which are not functioning properly.
4. Relaying of 250 meters long deep sewer line which is not functioning.
5. 5 Group Housing Colonies are connected with SW drain but not connected with Trunk Sewer. Scheme should be prepared for their connectivity.

Mr. Ajay Kumar Gupta (AE) and other official will explain the whole problem. There are about 24 pumps which pump out these sewage into open drains.

East of Ring Road:

1. Lawrence Road and CETP.
2. Trinagar old area needs relaying of Sewage System as has been done in some streets by **Trench less Technology**.
3. **Golden Park:** The whole of this area is connected with Najafgarh drain, When I was MLA and you were Executive Engineer, a proposal was made, approved and was awarded to connect the old area with Bharat Nagar pumping Station. Big size pipe were brought on the site but no follow up action was taken in the matter. What happen to that nobody knows?

You are requested to bring the field report in connection with the above matters from the field staff in the meeting.
