The members of the delegation informed that they are residing in the Jhuggi Clusters for the last 15 years and presently there are 500 residents and most of them working nearby Keshav Puram.

Any such encroachment/removal action, especially in case where the encroachers stated to have been living in the area for the last 15 years, can only be done after proper planning, keeping the humanitarian aspects in perspective and unless a viable relocation plan is in place.

The said letter of Dr. Nand Kishore Garg, Hon'ble Member of Legislative Assembly, is therefore, being forwarded for appropriate action, keeping in view all aspects mentioned above, *please*.

MEETING AGENDA

1. Relocation of Jhuggis : A list of Jhuggis which has been demolished on 26 June, 2014 is being sent to you, which are eligible for relocation as per policy.
2. Allotment of flats under **Rajiv Ratan Awas Yojana** : In the list of 34 Jhuggi, 22 have already applied in July 2008 for the flat under **Rajiv Ratan Awas Yojana**.
3. The Jhuggis along Railway Track have been served notices by railway authorities to vacate the land by 15 July, 2014.

More than 50,000 flats have been constructed at various locations in the city. I shall be grateful if you kindly consider to allot flats for those who have already applied under **Rajiv Ratan Awas Yojana** in July 2008 and are very much eligible for the same.
