## MINUTES OF MEETING

A meeting was held on 05 Jun 2014 to discuss the issues raised by Dr. Nand Kishore Garg MLA (Trinagar Constituency). As decided in the meeting a site inspection of Trinagar Constituency was held by VC, DDA alongwith the team of officers of Engineering, Planing & Architecture on 10 Jun 2014. During the site inspection of Transport Centre, Punjabi Bagh the representative of Punjabi Bagh Transporters Association were called by VC, DDA to come to his office to discuss the problems in details of Punjabi Bagh Transport Centre.

The meeting as scheduled was held on 13 Jun 2014 at 5:30 PM in the Conference Hall, B Block, Vikas Sadan, where Dr. Nand Kishore Garg MLA with the representatives of Punjabi Bagh Transporters Association and Officers of DDA were present. The issues relating to this centre were discussed in details & following decision taken:-

1. It was observed that most of the area is unauthorisedly encroached. CLM/CLD/CE(NZ) to identify these encroachment and action be taken for their removal.

Thereafter Dir (RL) in the meeting informed that he has already issued a letter of allotment of parking site to the contractor on 13 Jun 2014. It was therefore decided that performance of the contractor shall be reviewed after 3 months and in case of negligence the contract be cancelled & may be handed over to the Association for maintenance on revenue sharing basis.
